We are reaching out to provide you with an update of your investment in AP Investment Fund. This year's election will affect the fund moving forward in different ways. Some changes will be in our favor. For example the recreational use of cannabis will be legal in the state of California beginning January 1, 2018. While other changes, like the fact that Jefferson Beauregard Sessions may become the next Attorney General may adversely affect us given his past negative comments on cannabis legalization.

- **Bud and Bloom dispensary opened on Black Friday.**

- **Constructions begins at one of our dispensaries in the City of Santa Barbara.**

In mid-November, we received a Public Works Permit for exterior construction. Our operating partner also completed final submission for the interior construction and is waiting for approval.

- **Planting has begun in our greenhouses.**

Our grower is in the process of setting up the equipment for the greenhouses and they are using strawberries to test environmental conditions, layout, connections for irrigation, drainage, boiler, etc. They are currently getting ready to build propagation tables and photoperiod lighting, and then they will plant the “mother plants” of marijuana.
