So, personally, I am leaning to having one at a time, but we still need to discuss it more.

Hey Dad,

I am attaching the information for the costs of the egg donor and surrogacy process. I want to know how you would like us to pay for this.

The Egg Donor Cycle with IVF for two sperm contributors is \$38,000.00. This has been paid in full on my corporate card. I have informed Anita and we have double checked this is a medical write off expense.

The remaining fee's are for the egg donor compensation and agency fees, which are \$31,650.00. We are mailing a check from our joint account for \$7,000.00 to the agency along with the completed paperwork and we need to fund an escrow account with our attorney in the amount of \$24,650.00 by early next week. How would you like us to handle this? This **NEEDS TO BE DONE BY NEXT WEEK!**

Upon completion of the above, we will have viable embryos for implanting into a surrogate. The remaining cost will be \$2,000.00 to transfer embryos to a surrogate, as well as surrogate compensation, which will likely be around \$50,000.00, plus any legal and escrow fees, which will likely be a few thousand dollars. This will take place when we begin the process of actually having the baby.
